AREAS OF APPLICATIONS

HOW TO USE

- Remove dust, dirt, oil and grease etc. present on the plywood surface.
- Stir material properly before each use.
- Apply 1st coat of BONDTITE AQUASHIELD evenly on whole plywood surface and leave it to dry for 10-15 minutes.
- Then apply 2nd coat same as explained above over 1st coat.
- For highly porous surfaces 3rd coat can be applied in similar way as explained above.
- After application, clean the brush and other tools with normal water.

STORAGE

Product should be stored below 40°C in a cool & dry place away from direct sunlight in properly tight container.
